Keep your member number handy and you'll also need to have your mobile number and/or email address registered on your account. If you don't, call us on **1800 005 166**.

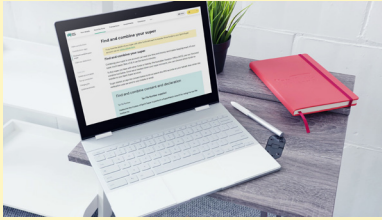

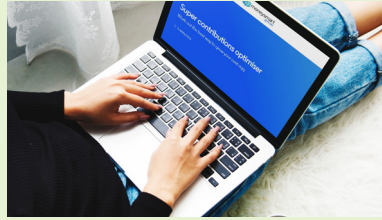

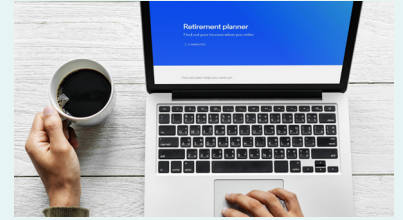
